## SUMMARY

This subject refers, on the one hand, to the fundamental questions included in the field of Philosophy and Theory of science and research methodology and techniques; on the other hand, it also deals with the set of issues that are dealt with within the field of knowledge of informative and audiovisual documentation, among others, the peculiarities of the documentary chain, the structure and functioning of documentary institutions and the treatment of documents, in this case audiovisual, even though the information and communication technologies are giving a transcendental relevance to the creation, management and use of the database.

The subject studies the nature, search, recovery and treatment of sources in the different areas of documentation related to the research and practice of Audiovisual Communication: 1) research in communication sciences; 2) exercise of digital, radio, television and multimedia journalism; 3) fact-checking; and 4) ideation and creation of photographic, sound, visual, audiovisual and multimedia projects.

## **OUTCOMES**

## **TEACHING METHODOLOGY**

#### **FACE-TO-FACE TEACHING**

Face-to-face teaching will take place in two weekly sessions, one for theory and the other for practical sessions, both lasting two hours.

- Lecture. The theory sessions will consist of the presentation of the subject's contents by the professor with the methodology of master class and with the support of the corresponding teaching materials. Attendance at these sessions is highly recommended, as they will serve to explain the concepts that students must apply in the practice sessions.
- **Theoretical and practical problem solving.** The practical sessions will take place in the computer room and will consist of the supervised resolution by the students of exercises introduced and proposed by the professor in relation to the theoretical content of the subject, using the problem-based learning methodology.

### NON FACE-TO-FACE WORK

The non-face-to-face work will be developed through the participation of the students in tutorials, the reading of reference texts provided by the teacher, the study of the knowledge presented in the theory sessions and the final resolution of the exercises proposed in the practical sessions.

## **EVALUATION**

The general grading system will follow the Regulation of evaluation and grading of the Universitat de València for bachelor's and master's degrees, approved by the Consell de Govern on May 30, 2017 (ACGUV 108/2017).

#### **FIRST CALL:**

The evaluation in the first call will consist of two blocks:

1. Final written test (50%): exam on the theoretical content of the course not covered in the practical



sessions.

**2. Assessment of technical learning (50%):** practical activities. Continuous and tutored realization of the exercises and problems raised in the practical classes, which will be delivered together in the last session of the course. The document to be evaluated will be the one handed in at the end of the course, as a result of the incorporation by the students of the suggestions and corrections made by the professor during the practical sessions. Each exercise will receive a maximum grade weighted according to the total number of problems posed and the number of sessions in which each of them have been developed.

#### **SECOND CALL:**

The evaluation in the second call will maintain, if it is the case, the grade obtained in the block passed in the first call. The evaluation of the failed or not presented block will be carried out in the following way:

- 1. Final written test (50%): exam on the theoretical content of the course not covered in the practical sessions.
- 2. Assessment of technical learning (50%): exam on the content of the practical activities.

#### **OBSERVATIONS:**

- It is necessary to pass the exam and the whole of the exercises in order to pass the course. In case of failing one of these blocks, its grade will not be averaged with the grade of the other block.
- Problems with spelling, syntax and/or written expression will be scored negatively and may result in failure of the test.
- All evaluable activities, except the exam, must be submitted through the virtual classroom. Documents submitted by other means will not be corrected. Each day of delay in the delivery of an activity will imply a penalty of 2 points (out of 10) in its evaluation.
- In case of plagiarism in a student's evaluation work, this may be evaluated with a numerical grade of zero, regardless of the disciplinary procedure that may be initiated and, if applicable, the appropriate sanction in accordance with current legislation.
- Intellectual honesty is vital to an academic community and for the fair evaluation of the student's work. All work submitted in this course must be originally authored by every student. No student shall engage in unauthorized collaboration or make use of ChatGPT or other AI composition software.
