La asignatura “Historia del Mundo Actual” forma parte de las asignaturas obligatorias del módulo de Formación Básica del 1º Curso del Grado de Periodismo. Tiene una carga de 6 créditos distribuidos durante quince semanas. Su objetivo básico es proporcionar una introducción a los procesos políticos, sociales y económicos de la historia contemporánea desde la posguerra mundial de 1945 a la actualidad. Se prestará especial atención a la dinámica histórica relacionada más directamente con los problemas actuales y con los ámbitos espaciales no incluidos en otras asignaturas del grado. Se otorgará particular atención a la historia europea desde una perspectiva internacional. El análisis de procesos amplios tendrá prioridad sobre el desarrollo de contenidos muy detallados.
