- To understand the concept of the State and its constituent organs:
- Distinguish the phases of the evolution of the State up to the present day, particularly the characteristic elements of the liberal State and its transformation into the Social State.
- To understand the institutional dynamics of the parliamentary system in its practical application to the Spanish case: functions of the Head of State and the technique of endorsement; the role of the General Courts, with special reference to the electoral formula and the legislative procedure; the relationship of trust between Government and Parliament; the Judiciary; the Constitutional Court and, in particular, procedures for the control of constitutionality.
- Determine the competence framework of any legal regulation and know the institutional system of the Autonomous Community of Valencia within the general constitutional framework.
- Knowing the concept of the Constitution as a legal norm and the system of sources Properly handling the fundamental concepts of the Theory of the Constitution, fundamentally, the concept of the Constitution and its instrumental notions.
- Understand the normative meaning of the modern concept of the Constitution and its implications for the system of sources. Determine the position of any legal norm in the current complex system of sources. Ability to identify the sources of Law applicable to any legal problem and to be familiar with codes or legislative compilations in order to be able to search for rules using different criteria (chronological, systematic or analytical).

4. The Constitution and the sources of Law

The Constitution as a legal norm and the constitutional system of sources of Law. The jurisprudence of the Constitutional Court. International treaties and European Union Law in the source system. The Law and regulations with the force of law. The rules.

5. Basic aspects of the economic Constitution

The projection of the Constitution on the Economy. Economy and Treasury in the Spanish Constitution. Economic model of the Constitution.

6. The institutional organization of the State (I)

The Head of State: significance of the institution and functions of the King. The endorsement. Constitutional regulation of the Crown.

7. The institutional organization of the State (II)

The General Courts: characters and composition. Organization. Functions. State's general budgets. Court of Accounts.

8. The institutional organization of the State (III

The Government: appointment, composition and functions. His relations with the Cortes Generales. Government and Administration.

9. The institutional organization of the State (IV)

The Judicial Power: its constitutional configuration. The Constitutional Court: organization and operation, control of constitutionality of laws and constitutional conflicts



10. The territorial organization of the State

State Constitutional state and territorial distribution of political power. Construction, development and evolution of the State of autonomies. The territorial organization of the State in the Constitution: characteristics and principles. The process of constitution of the Autonomous Communities and approval of the Statutes.

- . The instructor in charge of the subject may determine, in the annex to the teaching guide, the possibility of changing (based on a well-founded reason) the type or modality of the final exam when forced to provide an alternative date to the official exam date. This is pursuant to the rules for cases of exam schedule overlapping established in Regulation of Evaluation and Qualification of the Bachelor and Master Degrees of the University of Valencia, or any other regulated cause (e.g. cases of justified force



majeure). In these cases, the new type of exam must maintain the same level of demand and difficulty as the one taken in the official date.

The overall rating will be distributed as follows:

In order to pass the subject, and to be able to calculate the weighting with the continuous evaluation, it will be necessary to have obtained at least a minimum mark of 5 out of 10 in the global test.

The grade obtained in the continuous evaluation will be reserved for the second call of the same academic year.
