1. Different dimensions of professional praxis. Career training, career prospects. Professional praxis environment

1.1. Career training and labour aspects.

University and translators training. Seeking employment as a translator: freelance, translation companies/agencies. Labour, fiscal, etc., introductory aspects.

1.2. Professional praxis of institutional translation.

Translation in international organisations. Diplomatic translation. Translating for the European Commission. Translating and interpreting for the Spanish and Valencian administration. Legal translation.

1.3. Professional praxis of translation in other fields.

Literary translation. Audiovisual translation. Specialised translation. Localisation. Professional, labour, etc., specific aspects. Specific requirements.

1.4. Professional praxis of interpreting.

Interpreting vs. Translating. Interpreting in lectures: as a freelancer, in official institutions, etc. Social interpreting. Professional organisations vs. Professional societies. Professional, labour, etc., specific aspects. Specific requirements.

- 1.5. Deontological codes from different translators organisations.
- 1.6. Monographic approach of legal translation.

Career opportunities of legal translators: working as a freelancer, creating translation companies; legal translation. Translating as an economic activity. Career training requirements. University training, continuous training and collaborative learning in virtual environments.

2. Ethics and deontology when translating

2.1. Basic contradictions in translation practice and the ethics and deontology behind them. Divisibility and indivisibility of forms and senses. Translators freedom and fidelity. Visibility and invisibility. Ethic dimension and room for doubt. The vocational dimension of translatological praxis. The joy of translating. 2.2 Translatological praxis. The scope and limits of decision-making. Sense and principles at risk when using different translation procedures and methods. Implications in relation to different types of texts,



focusing on creative and humanistic texts. Matters of translatological creativity.

2.3 Dimensions of translation responsibility. Responsibility according to the contents of the original text, to the author, to the client or developer, to the addressees of the translation, to the expressive means or to other translation professionals. Corresponsibility and general principle of cooperation. Costs and benefits of translating. The translators rights. Natural ethics and professional deontology.
