# **TEACHING METHODOLOGY**

The Master's Final Project is an eminently personal activity. The student will need to devise and carry out an original research and set forth the results in an academic work in writing as well as to read it publicly. In this way, the student will need to demonstrate that he/she has correctly applied the knowledge and research techniques learnt during the Master.

This character is reflected in the distribution of the student's time commitment:

### CLASSROOM

**ACTIVITIES** (5% commitment = 18 h.)

Personalised tutorials in which the professor guides the student's autonomous learning process and solves the problems that arise in the research. (0.75 credits).



### DEVELOPMENT OF INDEPENDENT WORK (95% commitment = 357 h.)

Searching, reading, selection, and analysis of information, drafting the academic work and its public reading. (14.25 credits).

Postgraduate degrees at the University of Valencia are integrated in a distance learning platform, called "Virtual Classroom", that is a top resource for students training, complementary to theory and practical classes, seminars and the rest of supplementary activities. Through this platform, professors and students can maintain ongoing communication, plan academic activities and have material, documents and all sort of information available in relation to the corresponding courses, as well as professors are able to review and evaluate the students training tasks.

# **EVALUATION**

The Master's Final Project consists of an original research on any historico-artistic topic, the results of which will be set forth in writing as

well as read publicly by the students. In this way, the student will need to demonstrate that he/she has correctly applied the knowledge and research techniques learnt during the Master and that he/she has achieved the objectives proposed in this module. Evaluation will be based on a public reading of the project, which will be submitted forehand in writing, and heard by a tribunal composed of three PhD professors appointed by the Master's Academic Commission.

The evaluation criteria are as follows:

- Adequacy of the work to the tutor's directions.
- Quality of the status of the issue with regards to the selected topic.
- Analytical skills.
- Ability to argue mastering the specific terminology of the discipline.
- Quality of the written statement, according to standards of the discipline.
- Quality of the oral presentation.

The general grading system will follow the regulations of the University of Valencia, approved by the Consell de Govern on 27 January, 2004, in compliance with the Royal Decrees 044/2003 and 1125/2003.
