Initiation to research is carried out through the research lines of the universities participating in the master's degree in which the different professors are included. Some of them are: Symbolic language on ceramics in Antiquity, American Art of Antiquity and the Modern Age, European relations between East and West, Art and architecture in the Crown of Aragon during the Middle Ages, Art and daily life in pre-industrial societies, Architecture and urban planning in the Hispanic World during the Modern Age, Figurative arts in the Hispanic World during the Modern Age, The representation of power in Europe and America (16th-19th centuries), The representation of animals and plants in art (17th-19th centuries), Valencian artistic culture in the Modern Age, Architecture, engineering and town planning during the Contemporary Age, Valencian artistic manifestations during the Contemporary Age, Mass reproduction images in contemporary culture, Architectural photography, Cinema and other audiovisual media, Music and Visual Culture, History of the decorative arts, Art and Nature, Art, gender and new technologies, Historiography and sources of Art History, Iconography and Iconology. ## CLASSROOM

**ACTIVITIES** (5% commitment = 18 h.)

Personalised tutorials in which the professor guides the student's autonomous learning process and solves the problems that arise in the research. (0.75 credits).

Searching, reading, selection, and analysis of information, drafting the academic work and its public reading. (14.25 credits).

The Master's Final Project consists of an original research on any historico-artistic topic, the results of which will be set forth in writing as well as read publicly by the students. In this way, the student will need to demonstrate that he/she has correctly applied the knowledge and research techniques learnt during the Master and that he/she has achieved the objectives proposed in this module. Evaluation will be based on a public reading of the project, which will be submitted beforehand in writing, and heard by a tribunal composed of three PhD professors appointed by the Master's Academic Commission.

The evaluation criteria are as follows:

- Adequacy of the work to the tutor's directions.
- Quality of the status of the issue with regards to the selected topic.
- Analytical skills.
- Ability to argue mastering the specific terminology of the discipline.
- Quality of the written statement, according to standards of the discipline.



- Quality of the oral presentation.

The general grading system will follow the regulations of the University of Valencia, approved by the Consell de Govern on 27 January, 2004, in compliance with the Royal Decrees 044/2003 and 1125/2003.
