## SUMMARY

In the realization of the MASSDE, External Practices are compulsory. This course is intended for the master's student to make an experience of immersion of an applied nature in the resources and equipment for the care of dependent people, mainly people with disabilities, mental illness or elderly people who need situations of support and attention for events of daily life.

However, the students of the master come from different degree formations, in the course of which they may have had occasion to know from their specific disciplinary and professional perspective the area of care for dependency. Thus, through the external practices of the master, it is intended that they reach a higher degree of professional qualification, specializing as managers of resources and equipment for the care of dependent persons.

To do this, in the course of their practices they must be able to (a) recognize the different professional figures involved in such equipment, as well as their main competencies and action programs, and (b) acquire knowledge of organization, coordination and participation required for the operation of said resources and equipment.

It is particularly important, therefore, the acquisition of

- Cognitive skills related to the knowledge of organizations and planning of equipment and resources

- Problem solving and decision-making strategies for the operation and management of such equipment and resources

- Learning of ways of coordination and teamwork among the different professionals involved in the management of such equipment and resources

- Motivation to develop the initiative and entrepreneurial spirit in management, as well as concern for the quality of resource management and program execution

- Ethical commitment to understand and support people in need as an objective of managing these resources.

# PREVIOUS KNOWLEDGE

#### Relationship to other subjects of the same degree

There are no specified enrollment restrictions with other subjects of the curriculum.

#### **Other requirements**

Since the offer of external practices, although wide, is necessarily limited, the assignment to them will be done in order of scoring in the scale of admission to the master, taking into account previously the preferences of each student.

In order to favor the choice of institutions, informative sessions will be held jointly with those responsible for ADEIT in which the students will be informed about the conditions of the practices, the institutions that participate in them and the management procedures.

Once the contract for external practice has been formalized and the face-to-face activity in the institution begins, a procedure for monitoring compliance with the objectives of stay will be implemented.



# **EVALUATION**

The evaluation and qualification of the subject will be subject to the provisions of the **Regulations of External Practices of the University of Valencia, approved by the Governing Board of the University of Valencia on June 26, 2012, ACGUV 131/2012, and the Royal Decree 592/2014, of July 11,** that regulates the completion of training practices in companies and institutions by University students.

The evaluation of learning will include the follow-up of the student's attendance to the practices, as well as the verification of the theoretical and practical knowledge acquired and the completion of the tasks assigned. The competencies will be evaluated in relation to the objectives proposed in the framework program of practices based on monitoring indicators that account for their achievement in terms of knowledge, instrumental, expressive and proactive skills. The assessment of the external tutor will be taken into account, as well as the periodic reports, final report and / or project, with the assessment of the tutor of the university that has to give an account of the evaluation synthesis.

The qualification of the practices is a function of the evaluation in two sections:

**Section 1. Evaluation of the external tutor.** Royal Decree 592/2014 that regulates external academic practices, as well as our External Practices Regulation, establish that the company tutor must issue a final report of the practice, both for curricular and extracurricular practices. The tutor of the company or institution has to prepare a report, which will be sent to the academic tutor, which must include, at least, the most relevant aspects related to the degree of compliance with the practice in relation to the training project and the competences developed by the student.

**Section 2. Evaluation of the academic tutor.** The academic tutor will evaluate the work or memory of practice report, in which the student reflects what they learned during the period of stay in the resource chosen by the student. It must contain the following sections:

The evaluation of the two sections will be carried out using a scale that ranges between 0 and 10 points. The final grade will be the result of calculating the weighted average between the two sections that make up this module. The grading system will be expressed by numerical qualification in accordance with the provisions of the regulations (RD 1125/2003 of 5 September) by which the European credit system and the grading system are established in university degrees of official and valid character throughout the national territory.

Siguiendo la INSTRUCCIÓN RESPECTO A LA ADAPTACIÓN DE LAS PRÁCTICAS EXTERNAS DE TODAS LAS TITULACIONES A EXCEPCION DE LOS GRADOS EN MEDICINA, ENFERMERIA, MAGISTERIO Y MU DE PROFESORADO DE SECUNDARIA, A LA PANDEMIA DE LA COVID-19 PARA EL CURSO 2020/21, de 7 de enero de 2021 del Vicerrectorado de Empleo y Programas Formativos, se recogen los siguientes cambios en la Guía Docente de la asignatura:

- Para el estudiantado matriculado de prácticas externas curriculares en el curso 2020/21, la realización de prácticas presenciales se podrá llevar a cabo, con carácter ordinario, siempre que no haya nuevas instrucciones por parte de las autoridades pertinentes.
- Se podrán autorizar ordinariamente, mediante el procedimiento habitual de asignación de prácticas por parte de la coordinadora, prácticas en las modalidades a distancia o semipresencial (combinación pactada con la entidad cooperadora de una parte de las horas presencialmente y otra por medios telemáticos).
- Se amplía el periodo de realización de las prácticas curriculares durante todo el curso académico (hasta septiembre de 2021), si así fuera necesario. Se garantizará, por tanto, la evaluación del estudiantado que termine las prácticas en fecha posterior al cierre de actas.
- Las prácticas externas podrán desarrollarse siguiendo las directrices marcadas dentro de cada comunidad autónoma y respetando siempre los protocolos establecidos por las autoridades pertinentes.
- Cuando las prácticas no se puedan cursar en su totalidad durante el curso académico, los Directores de la titulación, la coordinadora de prácticas externas y la Comisión de Coordinación Académica del Máster, arbitrarán soluciones alternativas que garanticen su desarrollo, supervisión y evaluación numérica, en función del grado de realización alcanzado y competencias a desarrollar, que incluirán trabajos dirigidos por los/as tutores/as. Los estudiantes deberán incluir en la Memoria las tareas, actividades, o trabajos complementarios realizados.
- Se podrá considerar como medida sustitutoria de las prácticas el reconocimiento académico de experiencia profesional o prácticas extracurriculares previas. En este caso, el/la estudiante deberá acreditar ante la Comisión de Coordinación Académica del Máster la documentación que se le requiera.
- Con el fin de garantizar la finalización de la asignatura de TFM, en el caso que incluyan prácticas externas que no se puedan realizar en su totalidad, se desvincularán de las mencionadas asignaturas, independientemente que se especifique en el Verifica.
