SUMMARY

On the subject of ethics, professional ethics in clinical practice and research and regional and state legislation in the field of drug addiction will be treated.

In addition to sessions of lectures, seminars will be organized as clinical cases will be discussed, will also organize workshops on specific topics of current involving experts in the field that will be opened to debate (cocaine addiction treatment, prevention and scientific evidence, decriminalization, legalization, etc.).

In addition, the coordinators of the Master will propose the assistance and intervention in congresses of the specialty such as those conducted periodically by Socidrogalcohol, Spanish Society of Addiction, or the National Plan on Drugs and Addictive Disorders Network.

TEACHING METHODOLOGY
