SUMMARY

The subject involves two parts. The first one introduces the students into the matters arisen from immigration, foreign issues and conflicts that could arise from the differences between cultures and the individual and collective perceptions that are usually developed in the Spanish community, since the increase of population movements during the last decades.

TEACHING METHODOLOGY

The student, by his part, has to engage actively in the learning by means of the previous reading of the lesson and the complementary materials that have established in the planning of the teaching of the subject. As well as the intervention in the debates that ocaionen in the forum of doubts or in the tutorías ruled no face-to-face.

The metodología educational of application will adapt to the circumstances and to the competitions that mainly want desarrollarr in the frame of the teaching between which stand out the resolution of practical problems and the development of the basic categories of the discipline.

EVALUATION

The evaluation of the matter will do through a questionnaire that will have to resolve through the virtual classroom, of the first part devoted to alienism. The second part of the matter devoted to the intercultural mediation will evaluate through a comment of film (oriented previously by the professor), adjusted to the content of the matter. All the activities are of individual character.

70% of the final note will be the sum of the resolution of a questionnaire that will have to resolve in the day and schedule that prefix, and this through Virtual Classroom like "Tavern" (35%) more the comment of film (35%).

The rest of the evaluation of the subject (30%) composes in addition to

-Assistance to class: 2 points

-Participation in session of the professor invited: 1 point (if there was it) in contrary case will award by the participation in class.
