## **TEACHING METHODOLOGY**

At the beginning of the course the student will communicate if he wants the Master to look for a host company or institution or if he prefers to look for it by himself. In any case you must have the approval of the module coordinator.

The Master will try to guarantee a company or institution of welcome for all the student applicants of practices. The awarding of the scholarships corresponds exclusively to the coordinator of the module together with the companies offering the practices. If a student renounces the practice offered by the Master, he / she must search for the host company himself or wait for a vacancy to occur.

Once the practice is assigned, the student will receive notification from ADEIT to collect the documentation of the practice. Each student will have a tutor in the company and an academic tutor.

## **EVALUATION**

Both the student and the tutor in the company must complete an evaluation questionnaire about the company at the end of the practice. In addition, the student must make a memory. This memory must contain two different parts. A first part where the student describes the tasks performed by him, in the company where he has done the internship. And a second part, where you make a valuation about these tasks, and what can affect you; as well as, the future use that for him can suppose. Deadline for delivery Reports Evaluation: July 4.

The availability of both reports by the practices coordinator upon completion is an essential requirement to evaluate the module. The student will not be qualified until he / she submits both completion reports.

The final grade will reflect the predisposition, attitude and effective work done by the student during the stay. The final grade will be largely determined by the final evaluation submitted by the company's tutor, which represents 70% of the grade
