SUMMARY

Training in information skills or skills is aimed at mastering the access and use of specialized information resources in the area. The general objective is for students to be able to recognize when they need information, to have skills in locating, evaluating and communicating information, and to know how to use it effectively and ethically.

In order to be able to follow this module, the student must have attained the objectives and capacities described in the Subject "Informative Competences. Leveling for postgraduate ": must know and use the libraries of the Universitat de València (UV) and Basic information resources and services; At the basic level will know how to locate the information using different sources, access it, organize it and use it correctly respecting copyright and avoiding plagiarism.

The objectives sought are: - To locate specialized information in the field of gender law and violence. -



Use information resources effectively, at an advanced level. - Organize information effectively using a reference manager. - To know the criteria of quality in the evaluation of the magazines and the indexes of impact, with a view to the publication. - To know the current situation of scientific information regarding free access to information, Open Access movement and Creative Commons licenses.

At the end of this course the student will be able to: - Search information at the advanced level in the Trobes catalog and the Trobes + searcher - Search for specialized information in the bibliographic databases - Use the RefWorks bibliographic manager at an advanced level - Of specialized data in your area - Effective interrogation of databases - Locating judicial statistics - Locating impact indicators of publications - Identifying projects and movements related to the Open Access initiative in gender law and violence

LEARNING OUTCOMES

The aim of this module is diverse in its content but in its matching purposes. To support the one hand , the search and systematization of documentary sources, as essential for the commencement of an investigation preparatory task . In this task becomes very important efficient use of new technologies, especially the bibliographic management and document databases , as well as the internet itself, since more and more information is in it and not in hardware deposited in libraries . This knowledge is basic to explain what the research method and its different stages, without neglecting attention to the skills and attitudes to be met for a researcher , as well as instruments and suitable for successful research environment. In particular, the choice of subject and director of work will be discussed , it will search and systematization of sources supporting those , but especially to them in person at a library and finally the organization of work will be discussed and efficient use of time.

In turn, this learning must ensure the correct wording of a research and their subsequent communication . Correct understanding and implementation of administrative work required for a research presentation and / or a thesis that must be defended publicly will also be monitored .

All previous knowledge, will be finally implemented the face - served nature of this module, a methodological and transversal workshop on prevention and public awareness on violence against women that is presented as an essential practical addition .

TEACHING METHODOLOGY
