SUMMARY

The Master's Degree (TFM) is the logical conclusion of the Master's Degree. Although the programme offers students the possibility of acquiring an advanced set of knowledge on certain key aspects of gender violence (concept, fundamentals, approach, victim protection, risk assessment, judicial and police protection, etc.) it also has a clear academic dimension: it qualifies students for access to the Doctorate Programme in Human Rights at the Faculty of Valencia. The work will allow the student, through the handling of the documentary sources explored throughout the Master and the methodological knowledge acquired in the methodological training phase, to elaborate the research work on some of the multiple topics of debate that may arise throughout the previous Modules.

TEACHING METHODOLOGY

The elaboration of a Master's thesis does not have its own teaching methodology but clearly projects the methodological knowledge as well as the nouns acquired in the previous modules. The work is carried out in constant coordination between the director and the student.

Therefore, it includes those that are typical of a management task:

- Tutorials and discussion with teachers. Consultation of doctrinal and jurisprudential materials and legal methodology.
- Discussion of the report with the tutor assigned to the final master's work.
- Preparation of the final project.



- Preparation of the presentation, defence and public debate of the Master's thesis with the examining board.

EVALUATION

Procedure for the defense and evaluation of the TFM:

In the authorization document of the deposit, the director of the TFM will indicate whether, in his/her opinion, the TFM should be subject to public reading or, on the contrary, it should not be subject to public defense, being evaluated by the Tribunal without intervention or debate with the student.

In the event that the defense of the TFM proceeds, the student will have a presentation time of between **10 and 15 minutes**, according to the Tribunal.

The work may also be assessed by a Tribunal with identical characteristics to those described above, with the difference that the students will not attend in person, as there will be no interaction or debate. In this case, the maximum mark to be obtained by students in these circumstances will be **6**.

In any case, the assessment of the work will be carried out in accordance with the rules drawn up by the Academic Committee for this purpose. The deliberations of the panel are secret and, once they have been completed, the person presiding over the panel will inform the student of the grade obtained.

Date, place and evaluating Tribunal:

The date, place and tribunal will be set by the Directors of TFM who will communicate to the CCA both the date, place and time for approval.
