SUMMARY

Project (TFM) is a mandatory subject of the Master's Degree (12 ECTS credits), consisting of a research work that the students

carry out autonomously under the guidance and direction of a Director and that is defended before a Court. once it has been

previously deposited. The Master's Degree (TFM) is the logical conclusion of the Master's Degree.

Although the programme offers students the possibility of acquiring an advanced set of knowledge on certain key aspects of gender violence (concept, fundamentals, approach, victim protection, risk assessment, judicial and police protection, etc.) it also has a clear academic dimension: it qualifies students for access to the Doctorate Programme in Human Rights at the Faculty of Valencia.



The work will allow the student, through the handling of the documentary sources explored throughout the Master and the methodological knowledge acquired in the methodological training phase, to elaborate the research work on some of the multiple topics of debate that may arise throughout the previous Modules.

LEARNING OUTCOMES (RD 1393/2007) // NO CONTENT (RD 822/2021)

This module aims at the practical execution of a research work through the choice of a research method, the correct use of sources, planning, writing and communication and public defense of the research. Likewise, it allows students to supervise the execution of the administrative procedures required for the presentation of a research work and/or a doctoral thesis that must be defended publicly.

During this period, the techniques learned will be used to develop the research work and its results must be publicly presented before a commission and its consistency, coherence and objectives achieved must be defended. Knowing how to write is essential to be able to specify the result of the research, as is knowing how to communicate it regardless of the audience to which it is directed. To this end, the techniques to obtain both skills will be taught.

After having taken this subject, students will have acquired the ability:

1. Both in the conceptual, methodological and formal content aspects of carrying out a feminist and gender research project in accordance with a university master's level.



2.- To demonstrate the ability to carry out a bibliographic review and build a theoretical framework based on feminist theories and the gender perspective.

3. To define a relevant research problem in the matter, design and use the methodologies appropriately, collecting the necessary data and information and carrying out an analysis and interpretation of results consistent with the purposes set out in the work

TEACHING METHODOLOGY

Use of individualized methodology adapted to the student. The director, through discussion of topics, recommendation of readings,

participation in support activities, in debate forums and presentation of contributions, specific methodology courses, coordinates

and guides the student's training so that they acquire the tools of the activity.

Therefore, it includes those that are typical of a management task:

- Tutorials and discussion with teachers. Consultation of doctrinal and jurisprudential materials and legal methodology.
- Discussion of the report with the tutor assigned to the final master's work.
- Preparation of the final project.
- Preparation of the presentation, defence and public debate of the Master's thesis with the examining board.



EVALUATION

Procedure for the defense and evaluation of the TFM:

The assessment will be carried out in accordance with the Regulations for the development of the Master's Final Project, approved by the UV Governing Council on 25 July 2017, the UV Assessment and Grading Regulations for Bachelor's and Master's degrees, approved by the UV Governing Council on 30 May 2017, and the instructions issued by the Academic Committee of the Master's Degree.

With few exceptions, the work will be defended in person before an examining board made up of three PhD lecturers from Departments that teach on the Master's Degree, chosen by the Director and appointed by the Academic Coordination Committee.

- Students' presentation time: Between 10 and 15 minutes, as set by the examining board.
- Maximum time for discussion with the examining board: 15 minutes.
- If the student intends to use slides or other elements to support the presentation, this must be notified at the time of submission.
- The defence of the TFM requires the previous fulfilment of the requirements for the deposit as well as the rest of the required formalities.

Date, place and examining board:

The date, place and examining board will be set by the TFM Directors who will inform the CAAC of the date, place and time for approval.

Assessment: in accordance with the University of Valencia Assessment and Qualification Regulations, approved by the Governing Council on 30 May 2017, the TFM will be marked with the following grades:

$0 \leq \text{Fail} < 5$

$5 \leq \text{Pass} < 7$

$7 \leq \text{Merit} < 9$

$9 \leq \text{Excellent} \leq 10$

In the event that the mark for the work is equal to or higher than 9.0, the defence report will also indicate whether an honours degree is proposed. One honours degree may be awarded for every twenty students, so the award may be made once all the defences of the course have been completed.
