DESCRIPTION OF CONTENTS

1. Seminar. Domestic and Funerary Archeology in the Mediterranean

This course is part of the seminars in which visiting professors or the Master own, present the results of ongoing research projects. Its theme will focus on different aspects of research problems related to prehistoric and archaeological lines

Masters research, so that students are familiar with and can choose from among those that will be further development in his Doctoral Thesis.

Order to guarantee a minimum of variability to facilitate the choice by students of their future thematic work is planned offer five optional seminars, which may vary in some cases between academic courses, which will be chosen 4. 12 credits ECTS.

In this seminar that discusses the Domestic and Funerary Archeology in the Mediterranean, it shall, in the first session, the presentation of objectives and content, and a proposal of recommended readings to follow the seminar. In subsequent sessions will comment and discuss these readings and case studies presented a joint analysis of case studies.

2. Tutored Work

Work carried out by students under the supervision of a tutor and aims to develop students' skills to face an issue researcher.

The topic will be determined by mutual agreement between students and tutors in the interest of the first. The activity involves an archaeological approach to a topic that is developed from literature sources and / or empirical.
