## LEARNING OUTCOMES

The objective of the External Practices is to improve the capabilities and complete the integral formation of the students and the students, to enable them to be incorporated into the world of work with a more professional experience and human. The student will be integrated into the professional world of the hand of a tutor or tutor in the faculty and another in the external entity (company or public entity or third sector).

The duration of these curricular practices is 150 hours.

## TEACHING METHODOLOGY

Consist of a work placement in an organization with the follow-up of a tutor, but in order to get to that point you must first select the entity in which to carry out the internship.

### Instructions for the selection of External practices

- Adeit will inform about the list of entities with which they have contacted and answer affirmatively in offering places for the master. This provisional list will be passed before Christmas so that students can get an idea of the possible entities with which they will collaborate. Later in January the definitive list of places will be informed.



- On the other hand, students will be informed with another list of possible research entities / institutes, etc. with which they could contact to request an autoprácticum.
- Due to the profile and contents of this master's degree, autoprácticums will not be recognized in companies that do not have any relationship / collaboration with the public sector. For example. Banks, insurers, etc. are not valid, but NGOs do, if they receive public aid.
- When the information on the places offered is final, students will be gathered to make the final selection of places. That day, staff from ADEIT will come to explain the process of operation of the practices and the relationship between Adeit and the entities.
- The day of selection of the places the students will choose according to their preferences in the first place. In case there is a tie for the selection of a place, the student will be allocated by lottery.

### **Instructions for the development of External Practices**

- Each student must have received a Dossier of Practices that contains:
  1. Useful information on the development of practices.
  2. Yellow instruction sheet.
  3. Letter of presentation that must be delivered to the tutor of the practice center.
  4. Agreement of practices (five copies): the student must collect all the signatures (and seals) of the indicated persons. To the left of the agreements is indicated who has to deliver each copy: student, company, academic tutor, administrative services of the master (Carlos Ochando and M<sup>a</sup> Ángeles Tortosa) and ADEIT (can also be delivered to Carlos Ochando / M<sup>a</sup> Ángeles Tortosa) or deliver to Inmaculada Ferragud in ADEIT offices.
  5. Student evaluation sheet.
- The centers where the practices will be developed are notified and await the students. Before presenting yourself at the center, you must contact the center's tutor to confirm the start of the internship on the indicated day. It is important to sign the internship agreements on the first day.
- As soon as you start the internship, you must hand in the signed copy of the internship agreement to each of the persons indicated, especially to the academic tutor. The student will have to indicate when the practice begins and ends to carry out the corresponding follow-up.
- If during the first weeks a serious problem in the development of the practices is detected, contact the academic tutor as soon as possible or Carlos Ochando / M<sup>a</sup> Ángeles Tortosa or Inmaculada Ferragud to solve / modify the practice.
- Once the internship is over, the academic tutor must be informed of its completion.

## **EVALUATION**

For the evaluation of the practices:

- the student must deliver a Practice Report to the academic tutor (a schema of the content to be presented in the practice report will be included in the virtual classroom).
  - the student should ask the entity's practical tutor to complete the student's evaluation form
2. The final mark of the practice will be composed of:



- a) 80% assessment of the company tutor
- b) 20% practice memory
