SUMMARY

This course is part of the protection of minors, taking as a reference the work carried out by the United Nations as well as Law 1/96 on the protection of minors, taking into account the prevalence of the best interests of the child in all cases. To do this, it provides students with a theoretical-methodological and legal framework of reference that can serve as a guide in intervention with minors, in a context of a knowledge society such as the current one in which the right to protection must be resolved in the various fields that define communication technologies. Along with this, the course also delves into the measures and resources that the child protection system offers, especially in cases of minors at risk and / or homelessness, also highlighting the relevant role of the family in relation to the good treatment of children and the development of resilience. All this is worked from a theoretical-practical perspective that allows students to be connected with the closest professional reality.
