TEACHING METHODOLOGY

MD2 - Individual study. The student is directed in learning-oriented activities, so that student activity focuses on research, location analysis, handling, processing and return of information. The preparation work for the study of the subject will focus on it.

MD3 - Tutoring. Both individually and in groups to solve problems and direct jobs. You can use the platform "Aula Virtual" of the University of Valencia to maintain contact with the teacher.

EVALUATION

In order to achieve a certain degree of homogeneity in the classification of work to master, set out below the indicative criteria approved by the Academic Coordination Committee (CCA), in accordance with established in the Regulatory Regulation of Master's Thesis in the University of Valencia approved by Agreement 199/2017, of 25 July 2017, the Consell de Govern of the University of Valencia (ACGUV 199/2017).

TFM assessment should refer to the acquisition of the tasks set out in the document verification official title of Master.

The student should proceed to the public defense work to master in fornt of the evaluators under the conditions established by CCA (art. 18.1 ACGUV 199/2017).

The tutor sent to the president of the evaluators, prior to the public defense of final master work, a report on it (art. 17.3 ACGUV 199/2017). At this point the CCA recommends that the report includes a proposal tutor qualification work. After the defense of the TFM, the evaluators will proceed to their qualification. The evaluators will consider the proposal to make its decision. If there is no agreement between the evaluators and the rating given by the tutor, it is recommended that the final grade is the average of the four individual scores. In this case each of the members of the court shall issue a detailed report of its rating.

The TFM will be scored numerically from 0.0 to 10.0 to one decimal place.

The board members sign a record of the defense which contain the numerical grade. In your case it is also displayed if the qualification of Distinction proposes (art. 19 and 20 ACGUV 199/2017).

For this purpose it is recommended that each evaluator and the tutor determine the qualification taking into account the following criteria:

- 1. Formal aspects of the work presented (25% of score). Among the formal aspects of the document would assess, among others, the following:
- Written Format: Quality of drafting, job structure, proper citation and presentation of the literature.
- Presentation and defense work: quality and clarity of oral / visual and adequacy of the means used presentation.
- In addition, the tutor of the TFM will consider the issues arising from planning, organizing and preparing the work prior to the presentation.
- 2. Work content (75% of score). Under this section, the court will assess, among others, the following:
- Difficulty / originality / novelty of the chosen theme.
- Level of contribution to the published literature.
- Degree of development work.
