SUMMARY

The module 44410 *Research in literature: Synchronic perspectives* is comprised of two units: *Literatures in contact* and *Literature and society*.

1. LITERATURES IN CONTACT

In this course we will study (transit) spaces, characterised by contact between cultures, in representative examples of Western literature from the 19th to the 21st centuries.

2. LITERATURE AND SOCIETY

This subject will revolve around the axes of migration, creation and interculturality, based on gender and postcolonial perspectives. Starting from sociological, anthropological and political elements, we intend to analyse different literary creations and contemporary cultural productions that emerge from new intercultural identities that are essentially the result of migration. Intersectionality will also be an important factor in our approach, seeking the interaction between different aspects that intersect and influence the social and cultural identities of our current postcolonial globalized context (gender, race,



class...) in order to analyse and make visible the systems of oppression and exclusion.

Analysis of a varied corpus of cultural productions (literary and audiovisual) from different geopolitical contexts that revolve around the axes proposed from a gender and postcolonial perspective. The specific list of productions will be provided at the beginning of the classes.

TEACHING METHODOLOGY

The methodology for teaching and learning is structured around face-to-face and distance activities.

The teaching methodology aims at encouraging students to learn actively and progressively, promoting the personal study of each of the units through class participation and the acquisition of theoretical and practical knowledge on the advanced theoretical principles of Comparative Literature (literatures in contact and cultural productions and society), its strategies and methodologies, as well as the analysis of the interferences among different literatures, cultural productions and semiotic systems.

EVALUATION

The assessment system for module 44410 Research in Literature: Synchronic Perspectives will be based on the control of the competences and knowledge acquired by the students. On the other hand, the assessment of learning will be completed with attendance, participation and the monitoring of the activities proposed in class.

In addition, students will carry out a final project for the module (focused on one of the two subjects: Literatures in contact [written paper] or Literature and society [oral presentation]) on a subject agreed with the lecturers. This choice must be communicated during the first month of class (February 2022). More precise indications will be given at the beginning of the semester (length, format, citation system and rubric used to assess this work).

- The assessment of the final project of the module will consider the requirements of a research paper, as well as presentation and grammatical correctness.



- Papers not submitted in the established form and within the established deadline will not be accepted. The minimum mark required for the final project will be 5/10 to be able to average it with the rest of the evaluable activities.

- The detection of plagiarism and the incorrect use of bibliographical sources in any exercise of the module will result in the failure of the same. The student may be called for an interview to discuss the work presented.

Type of assessment and percentages:

a) Final module project (written or oral): 50%.

b) Other assessable activities:

b.1) Literature in contact: Attendance (80% minimum) and active participation in class: 5% / Teaching Innovation Activity "rucksack 2.0.": 20%

b.2) Literature and society: Attendance (80% minimum) and active participation in class and other activities developed throughout the sessions: 25%.

Other issues to be highlighted:

- The final grade for the module will be the percentage sum of the grade for the final module work (a) either written or oral, and the rest of the assessable activities (b). The average will only be calculated if at least a grade of 5/10 has been obtained in both the final module work (a) and in the evaluable activities (b.1 and b.2).

- In the case of not submitting the module final project or not obtaining the minimum mark required in the first sitting, the student must submit or repeat it the second sitting. In this case, the marks of the other assessable activities (b) obtained in the first sitting will be kept for the second. These activities are not recoverable.
