SUMMARY

The Advanced Process Control course is a compulsory subject of 6 credits taught in the second semester of the Master of Chemical Engineering. The subject will be taught entirely in Spanish, with the exception of one of the two tutorial/laboratory groups that will be in Valencian. The aim of the course is therefore to provide an extension of the knowledge acquired in a basic control course that begins with the presentation of control techniques that go beyond classical feedback control techniques. It also aims to familiarize students with the problems that can be found in the control of complex processes as well as to present the basis for intelligent control systems. Given that more and more computers are used in control tasks, there is a chapter dedicated to digital control techniques where z transform is applied to the dynamic stability study. Finally, supervisory control and automation systems have an important consideration in the course.

The contents of the course to be developed on the program are:



Advanced control algorithms. Digital Control Systems. Multivariable Control Systems. Intelligent Control Systems: Fuzzy Control and Neural Networks. PLC's. SCADA Systems

- Describe the advantages achieved with process control with the operation of an industrial installation.
- Know different types of SCADA system for the monitoring and control of industrial processes.
- Describe the operation of a PLC and its programming to control processing units.
- Develop dynamic models of process units for using them in control algorithms.

TEACHING METHODOLOGY

The training activities are developed in accordance with the following distribution:

Theoretical activities

In the theoretical classes chapters will be developed to provide a comprehensive and integrated vision, analyzing in detail the key aspects and more complex issues, encouraging, at the same time, student participation.

Practical activities

Complement the theoretical activities in order to apply the basic concepts and expand the knowledge and experience they acquire during the performance of the proposed work. They can include any of the following types of classroom activities:

- Classes of problems and questions in classroom
- Discussion sessions and problem solving exercises previously developed by students
- Conducting group projects
- Lab and / or computers sessions.



Transverse activities

Visit to industrial facilities, attending courses, conferences, round tables and other types of organized and/or proposed activities.

Evaluation

Completion of questionnaires/individual written assessment tests in the classroom with the teacher's presence.

Tutorials

Mentoring activities by the responsible faculty.

The practical activities carried out during the course are not recoverable for the 2nd Call and the mark obtained for the 1st Call is maintained.

EVALUATION

To assess student learning, one or more tests including both theoretical questions as the resolution of a case will be taken and have a weight in the final mark of 50%. The rest of the mark will be obtained from the evaluation of practical activities such as preparation of papers, reports and / or presentations and laboratory report (40%) and the continuous evolution of each student, based on the regular attendance at classes, participation and degree of involvement of students in the teaching-learning process (10%).

The weighted average grade of examinations must be greater than 40 out of 100 to pass the course.

The assessment system is independent of the call (1st or 2nd).

ADDENDUM COVID-19

This addendum will only be activated if the health situation requires so and with the prior agreement of the Governing Council

1. Contenidos

Se reducen los contenidos inicialmente recogidos en la guía docente seleccionando los conceptos indispensables para adquirir las competencias. Concretamente se eliminan los contenidos del tema 5 ya que es un tema al que se le dedican pocas horas presenciales y no se ha encontrado una alternativa no presencial para dar el tema con garantías

2. Volumen de trabajo y planificación temporal de la docencia

En la guía docente se preveían 35 horas de clase de teoría, 15 de prácticas, 5 de laboratorio y 5 de tutorías en el aula, de las que han quedado por ejecutar 24 por la suspensión de la docencia presencial.

Se reducen en 24 horas las clases de teoría, y prácticas. Se mantiene el laboratorio ya que en el momento de la suspensión se habían ejecutado 3 horas y se dispone de un guion que permite la realización del laboratorio con ordenador. Se aumenta en 10 horas la preparación de las clases de teoría, en 5 la preparación de las clases prácticas, en 6 horas el trabajo autónomo y en 3 horas la resolución de casos prácticos. Para ello cada estudiante deberá hacer uso del material on-line y de las tareas propuestas a su disposición en Aula Virtual.

3. Metodología docente

Además del material que ya se encontraba en el Aula Virtual, se sustituye la clase presencial por transparencias con locución, de las clases de teoría y prácticas de problemas, localizadas en la plataforma mmedia de la UV con enlaces desde el Aula Virtual. Las actividades a realizar presencialmente en clase se sustituyen por “Tareas” de Aula Virtual cuya propuesta y ejecución podrá realizarse durante un período de tiempo prolongado, o durante un tiempo acotado a unas 2 horas. Se mantienen las prácticas de laboratorio que comenzaron antes de la entrada en vigor del estado de alarma.



Sistema de tutorías: Los dos profesores contestarán las dudas que vengan por correo electrónico o vía Aula Virtual (máximo 48 horas laborables).

4. Evaluación

Mantenimiento de las notas resultantes de la evaluación continua obtenidas antes de la entrada en vigor del estado de alarma aunque su peso cambia.

Incremento del peso de la evaluación continua del 40% en la guía docente al 50%. Se mantienen las actividades evaluables de manera continua de la guía original: resolución de problemas y laboratorio.

Reducción del peso del examen final del 50 al 40%. Se elimina el mínimo en la nota del examen para superar la asignatura. Se mantiene el 10% correspondiente a la asistencia presencial y la participación “on-line”.

No obstante, también se aplicará a cada estudiante los porcentajes de ponderación que aparecen en la guía docente original y se escogerá la calificación que resulte más favorable.

Prueba de evaluación final: Se basará en un examen con parte de teoría y problemas que se subirá al Aula Virtual como “Tarea” a la hora prevista para el inicio del examen. La duración del examen será de 3 horas. Será la hora que figure en la actividad “Tarea” del aula virtual como hora de entrega la que se tenga en cuenta para entender que se ha entregado en plazo. En su momento se darán instrucciones por si cada estudiante tiene que estar conectado mediante videoconferencia BBC con la cámara activada y el micrófono silenciado.
