SUMMARY

The penultimate module of the Master includes the internship period that ensures the critical assessment of the context of the intervention of the different conceptual approaches to the field of migration (demography, sociology, economics, politics, law, anthropology, psychology and other health branches. Practicum is a core subject of 9 credits of the Curriculum of the International Master in Migration, in which the student makes a total of 230 hours of practice The Practicum has two aspects: Professional and Researcher that will be reflected in Practicum's memory: The development of the practice has as its first objective to provide students with a deeper knowledge and the skills and attitudes of a migration expert, secondly, try to link the students with the reality of migration and complete The theoretical training with the practical experience necessary for the exercise of a migration technician ions All this in direct relation to the demand in the labor market. This learning takes place thanks to the collaboration with a professional who performs his activity in an external place of the academic field and under the guidance of a professor of thesame. It is, therefore, an experience lived in real work contexts. On the other hand, when choosing a research profile, you work directly with the research groups. Our master collaborates with a select and experienced group of internationally renowned institutes, which receives our students.

A critical assessment of the intervention context will be made from the different approaches to the field of migrations (demographic, sociological, economic, political, legal, anthropological, psychological and health).

TEACHING METHODOLOGY

The methodology carried out by the teachers of this module will combine, according to the type of activity carried out (theoretical class, practical class-workshops and tutoring) the following work modalities: teacher's presentation, group work and students' exposure to Starting from small projects, problem-based learning, tutorials, debates, text commentary and solution of particular cases related to the topic. Theoretical classes: They will be devoted to the analysis, study and understanding of the fundamental concepts included in the program of the subject. The most complex concepts and theories will be explained by The teacher and in all of them will be carried out, in the same session, exercises and complementary activities by the students to facilitate their understanding. Practical classes: Students will receive a notebook with the learning activities to be carried out, which will be related to the contents worked and studied. It will consist of the analysis of practical cases, search for information in different media, etc. Some of these activities will be presented and analyzed at the group-class level. It should be delivered, when established by the teacher, a notebook with all the practices performed, which will have a global assessment





EVALUATION

From the individual and group reflection on the practices, and deepening their keys, the student will individually prepare a Memory of Practices. The Memory of Practices must be the result of the student's reflection on the work done and the circumstances in which it will be developed. To do it you will need to request information about the practice center from your center tutor, an aspect that you will do while respecting the confidentiality of the information obtained. The Practicum Report will be specified by each tutor of the master's degree, depending on the activity carried out in the different places of practice. The student will deliver the report to his tutor before the date indicated in each module, including in it the selfassessment questionnaire that appears in the annex. Each tutor individually evaluates the students assigned in the Practicum module. The evaluation includes the following elements:(1) Assessment of the tutor of the practice center. It is the person who has been responsible for the direct tutoring of the student in practices, and can provide a reliable assessment of them, considering criteria such as student participation, integration into the work team, professionalism and responsibility, the initiative. This assessment is carried out through: The evaluation questionnaire. Interviews with the center tutor.2) Memory. In the Practicum the work done in the center is as important as the student's assessment of it. Both are presented in the Practicum Report, which is the fundamental working document of this module. This dossier includes the structure and key epigraphs of the Report, which can be qualified by each tutor. The fundamental criteria for the correction of the Report will be the following (qualified, if appropriate, by each tutor): Clarity and structuring of the presentation of the required data and information. Clarity, deepening and structuring of the analysis and reflection on the practices carried out. Clarity, deepening and structuring of the analysis and reflection on the role of the migration technician in the work / research area, and on the theoretical contributions reviewed during the master's degree (the subjects and their contribution). Adaptation to the specific objectives of the Practicum. Organization, presentation and spelling. Writing, documentation, argumentation, conceptual rigor and proper use of the specific vocabulary of the discipline.(3) Assessment of the tutor of the Faculty. The follow-up and reflection work done by the faculty tutor offers criteria for issuing their own assessment of the practices performed by the student. This assessment is mainly built on the following criteria: attendance and participation in meetings and follow-up seminars. Assessment of the practices, based on interviews with the tutor and visits to the center (student participation in the center, integration into the work team, autonomous work, professionalism). The final Practicum score is constructed from these three assessments, weighted as follows:Report of the tutor of the practice center 20% Assistance to tutorials, participation and assessment of memory 80% There are three situations that may lead to the failure to pass the Practicum, which implies a different recovery process:* If the internship period has been developed correctly, but the realization of the Report is incorrect or deficient, the student must repeat it and present it to his / her tutor of the faculty for the second call.* If the report of the center of practices, corroborated by the tutor of the faculty, is negative, and indicates important problems in the development of the practices, the student will have to enroll again and repeat the whole period of practices in the following course.* If the breach of the rules established by the master and the institution where the Practicum is carried out is incurred, the student must enroll again and repeat the entire period of practices in the following course.

ADDENDUM COVID-19

This addendum will only be activated if the health situation requires so and with the prior agreement of the Governing Council

The CCA of the master's degree has decided to maintain 100% attendance for the next academic year 2020-2021 with due security measures. Therefore, the conditions of the academic guide will continue to apply. But if as a consequence of COVID-19, it is impossible to carry out the practicum subject and its training in person (professionalizing practicum), according to the height of compliance with the established contact hours that the confinement occurs, the following changes:

- a) If 70-80% of the contact hours have been completed: the student will continue their practicum with a professional profile through teleworking.
- b) If 50-60% of the contact hours have been completed: the option of a change to a practicum with an investigative aspect will be evaluated with the student. In case of denying this option, the student can continue their practicum with a professional profile by teleworking.
- c) If less than 40% of the contact hours have been completed: if the training period has just started or less than 40% of the hours have been completed, the student will be offered the option of a change to a practicum with an investigative aspect.



1. Contents

There are no changes in the contents.

2. Volume of work and temporary planning of teaching

The ECTS credits of the subject are maintained as indicated in the teaching guide. But in cases (a) and (b) the following conditions will be met:

- a) If 70-80% of the contact hours have been completed: the student will finish their practicum with a professional profile by teleworking and will comply with the distribution of hours provided in the guide: 180h of resolution of practical cases; 45h of individual work and 2h of training classes (in the event that they have not already been done, they will be done in person).
- b) **If 50-60% of the contact hours have been completed:** if the student continues his/her practicum with a professional profile by teleworking. The academic tutor and the external tutor will determine the nature of telework, which will be aimed at complying with the 180 hours of resolution of practical cases planned by telematically substituting the remaining hours.

3. Teaching methodology

- Upload of materials to the virtual classroom
- Proposal of activities for virtual classroom
- Recorded transparencies
- Problems / exercises solved (practical classes)
- Tutoring by videoconference
- Forum in virtual classroom

4. Evaluation

The Virtual Classroom will be used for the delivery of the practice report or the official mail of the master and the Blackboard Collaborate platform, Skype or similar, for videoconferences with the tutors or other participants. If for any reason the student does not have virtual technical means, they will inform the teaching staff of their situation.



Teachers may require individual or small group interviews via videoconference to verify the degree of participation and the achievement of the objectives pursued in any task carried out. Decline this verification by the student will mean not passing the task/activity in question.
