a) That students demonstrate an understanding of a field of study related to migration and mastery of research skills and methods related to that field.b) That the students know how to apply the knowledge acquired and their ability to solve problems in new environments or multidisciplinary contexts related to the subject of migration.c) That students are able to perform a critical analysis, evaluation and synthesis of the publications reviewed.d) That students are able to integrate knowledge and face the complexity of making judgments based on such information, including reflections on the application of their knowledge and judgments.e) That students demonstrate the ability to conceive, design, implement and adopt a substantial process of scientific research.f) That students know how to communicate their conclusions and the ultimate knowledge and reasons that support them in a clear and unambiguous way.g) That the students know how to write the work / research report following the standardized regulations.h) That the students demonstrate learning skills that allow them to continue studying autonomously. The expression of all these competences must be reflected in the master's final project in the different parts of the written presentation. Therefore it is necessary to include a theoretical introduction. In addition, if field work has been carried out, it will be necessary to describe the most prominent method and results. At the end of the report, a theoretical discussion section will be included where the student values his work and its consequences in the theoretical framework where he has developed his activity and consider to what extent the experience has allowed him to complete the theoretical training of the Master's Degree in Migration.

INTRODUCTION: Description of the central argument of the work. Background on the subject and current state of affairs. Preliminary work of bibliographic and documentary search. Importance, novelty and social impact of this work. Objectives and how they were achieved.

THEORETICAL FRAMEWORK: Analysis of paradigms, models and theories in which the descriptive analysis is framed.

METHOD: Research design. Preparation of the material and planning of the sample collection. In your case, inclusion of interviews and / or questionnaires. In your case, participants, interviewed sample, or description of the operation of some centers, or analysis of the social application of certain policies. Approach of working hypotheses and verification of the same.

DISCUSSION AND CONCLUSIONS: Orderly presentation of the results obtained. Analysis of the results and conclusions.

# **EVALUATION**

The process to be followed for the evaluation of the Master's Thesis will consist of the presentation of the work in pdf format through the ENTREU electronic headquarters (UVEG) and its subsequent defense in a public act.

The following indicative calendar is recommended:

1. The student must contact the director of the TFM within a maximum period of two weeks from the communication of the assignment.

2. At least one month in advance of the estimated defense date, you must deliver the final draft for your final review.

3. Within the established period, the student must deposit the work through the ENTREU electronic office, in pdf format.

In his oral presentation, the student will have a maximum of 25 minutes to present orally before the court a synthesis of her TFM. She will be able to use the necessary material to support her oral presentation. Later, the court may ask the questions and comments it deems appropriate.

The court will qualify based on compliance with the competences and the rigor and quality of the TFM presented.

Assessment: The qualification obtained will be from: 1) The report presented (70%) 2) Exposure of the work (10%) 3) Defense of the same (20%).

### **ADDENDUM COVID-19**

The CCA of the master's degree has decided to maintain 100% attendance for the next academic year 2021-2022 with due security measures. Therefore, the conditions of the academic guide will continue to apply. But if, as a consequence of COVID-19, it is impossible to carry out part of the subject of the Master's Final Project (TFM), the following modifications of the guide will be taken into account:

#### 1. Contents

There are no changes in the contents.

#### 2. Volume of work and temporary planning of teaching

The ECTS credits of the subject are maintained as indicated in the teaching guide. But in the case of 7.5 hours of face-to-face teaching, if they have not been done at the time of confinement, they will be added at 150 hours of carrying out the project of TFM.

#### 3. Teaching methodology

- Upload of materials to the virtual classroom
- Proposal of activities for virtual classroom
- Tutoring by videoconference

#### 4. Evaluation



The Virtual Classroom will be used for public presentation before the court. The Blackboard Collaborate platform will be used for the presentation in court and this, Skype or similar, for videoconferences with the tutors. If for any reason the student does not have virtual technical means, they will inform the teaching staff of their situation.

Teachers may require individual interviews via videoconference to verify the degree of participation and the achievement of the objectives pursued in any task carried out. Decline this verification by the student will mean not passing the task / activity in question.
