Assistance to clinical practice. In this type of evaluation is taken into account,not only the student's presence in clinical practice, but their involvement in them. Thus, it will consider punctuality, student motivation to dealing with the patient and their relatives, the literature review on the maneuvers performed with the patient or the proposed activities for functional recovery, expanding knowledge and student interest in learning about the medical history of the patient and in providing innovative intervention techniques.

The portfolio will be both theoretical and practical classroom and external practical classes. In this document, students must translate the activities in each subject as a diary, and includes activities that the teacher ask for outside school hours.

It will be necessary to obtain at least a score of 5 in each part (attendance to practices and final memory), to pass the subject.

This addendum will only be activated if the health situation requires so and with the prior agreement of the Governing Council

This addendum will only be applicable if the health situation derived from Covid-19 does not allow the development of the subject according to the terms established in the academic guide.

1. Contents:

In the event that the suspension of the practices by the competent authorities in Public Health matters, prevents the students from receiving all the practical training of this subject (135 hours), the theoretical contents related to the subject, oriented to guarantee the achievement of the learning objectives.



2. Volume of work and temporary planning of teaching:

In case of temporary suspension of practices in the centers dependent on the Conselleria de Sanitat Universal i Salut Pública, the volume of work corresponding to external practices and their planning will be modified:

- You may opt for telepractice, in cases where it is possible and the acquisition of the skills of the subject is guaranteed.
- The hours of practice that cannot be done, will be transferred to the autonomous learning time of the students, by carrying out a specific complementary activity that they must include in their practice reports and deliver within the established deadlines.

Thus, the overall volume of work for this subject does not change.

3. Teaching methodology:

The hours of external internships not carried out (neither in person nor in telepractice modality) will be replaced by the development of a complementary activity of autonomous work, supervised by the care and / or academic tutors. In due course, through the usual means of communication with the student body of the University of Valencia (virtual classroom, institutional email), instructions will be provided to the students on the contents of the work to be developed, as well as its mode and deadlines. delivery.

The academic tutorials will preferably be carried out virtually. Following the guidelines of the University of Valencia, it is recommended to carry it out by videoconference through the Blackboard Collaborate or Teams platforms.

4. Evaluation:

The percentage of each of the elements of the evaluation of this subject (85% block of practices, 15% memory of practices), remains unchanged. The complementary activity will be included in the block of practices representing a percentage that will be established based on the hours of practices that the students have been able to do.
