Se presentan las cuatro libertades fundamentales de la Unión Europea y se analizan sus elementos delimitadores, su contenido, alcance y desarrollo legislativo: libre circulación de mercancías, de servicios (y su delimitación con respecto a la libertad de establecimiento), de personas y de capitales.

Se estudia también la regulación social en la Unión Europea, la libre circulación de trabajadores, la coordinación de los sistemas nacionales de seguridad social, los aspectos laborales de la libre prestación de servicios, la política de empleo de la UE, la igualdad de trato y no discriminación y la armonización de las legislaciones laborales nacionales.



Asimismo, se estudia la regulación presupuestaria y tributaria de la UE, las instituciones presupuestarias, la armonización tributaria y la consolidación fiscal e integración tributaria en la UE.
