SUMMARY

This course proposes to analyze, in an interrelated and pluralistic manner, liberal and illiberal political discourses and their cultural practices during the 19th century. With the methodological approach of transnational and specifically transatlantic history, the course will focus on the geographical space of Western Europe and Latin America. This methodology will be applied to political history, understanding "the political" in its broadest sense. This implies proposing three reconsiderations: the active role of politics in social change; the place of individual and collective agency in the processes of enunciation, negotiation and conflict; and, finally, attention to discursive procedures in the construction of individual and collective identities and actions, both national and racial and gender.

Analysis of the logic of absolutism and monarchical practices during the fin-de-siecle crisis.

2. Liberalisms and Constitutions in the Iberian worlds.

Analysis of the monarchical crisis, theory and practice of constitutional cultures, revolutions and independence and construction of nation-states.

3. Counterrevolution and Antiliberalisms in the Hispano-Atlantic space.

Analysis of the realist, counterrevolutionary and illiberal manifestations from the discourses and practices.



4. Beyond the Revolution

Analysis of liberal and illiberal political cultures in the second half of the 19th century.
